Audit – from a contractor’s perspective

Future Amtec specialises in the surveying and mapping of drains, sewers, water mains, pipelines, boreholes and other hollow structures. In many cases their asset investigation systems enable clients to survey structures that are unsafe for physical entry. Critical underground services can then be identified without the need for disruption and excavation.

The UK Utility industry is a key market with the water companies comprising the bulk of their business. This focus initially led them down the route of registering on UVDB and then Verify, the pre-qualification and audit scheme respectively. Future Amtec was recently acquired by Future Environmental Services, who have incorporated all services under their portfolio and have now also completed the same audit process.

The challenges

The nature of the surveying services Future Amtec provides means they frequently operate onsite in potentially hazardous situations. Due to the risks involved with the service the client will normally require a comprehensive vetting process. This is to ensure the contractor has the appropriate capabilities to carry out the work and help mitigate risk.

This can be a costly and time consuming process from both perspectives of buyer and supplier. Whilst good suppliers are always keen to demonstrate their capabilities, there is the frustration that there is often a huge overlap in the information commonly being requested by different clients.

The Verify Audit

The Audit scheme was founded by 4 UK Utilities in 2001. The key concept was to try and develop a shared approach to supplier assessment and establish best practice. The content was developed by H&S professionals and was initially targeted at contractors providing high risk services on their sites.

Today there are over 60 buyers, consisting of both utilities and major contractors, with access to over 1700 contractor Verify reports. The audit process and content continue to evolve with various types of assessment now available. Suitability is dependant upon company size and the nature of their service offering.

Audits are a key component of supplier pre-qualification, especially for higher risk contracts. These can include industry standards, recognised best practice or country-specific laws. The whole buying community can access a detailed report following the audit.
